



Indiana One Day Food Handler Course and Exam Schedule for 2017

As of January 1, 2005, Indiana requires that at least one person per food establishment, who oversees food safety operations, be a "Certified Food Handler", which means that a food service establishment must pass an accredited examination with a score of 75% or higher every five years. In order for you to meet this requirement, the Safe Food Handlers Corporation is offering a one-day course and a National Registry examination in convenient locations throughout the state of Indiana to enable you to acquire your 5 year certificate. Every five years, people must recertify by repeating this process of taking and passing another exam.

Comprehensive Food Service Sanitation Course Offerings

Our one day Comprehensive Food Handler Training course covers personal hygiene, safe methods of food handling, preparation & storage of food, prevention of foodborne illnesses, and HACCP. At the end of the day, a National Registry examination will be administered to enable you to obtain a 5-year certificate. The cost of the one-day course is **\$145** which includes a training manual, classroom instruction, and a National Registry Exam which is recognized nationwide. Examinations are available in English, Spanish, Chinese or Korean. **Students who do not show up for a scheduled class will be assessed a \$30 rescheduling fee.**
